3. The entire supplies shall be carried out under the supervision / instruction of our Consultant M/s. Datal Consultants And Engineers Limited, who may be consulted for commencement of work and any other assistance that you may require.
4. The seller shall supply the ordered items within 4 (Four) months from the date of this order as stipulated in Clause No. 1 of General Terms & Conditions of Purchase order.
5. You are required to pay a Security Deposit of Rs. 1,00,000/- (Rupees: One Lakh only) in cash/cheque/draft or in the form of Bank Guarantee as per the enclosed proforma against this purchase order as per Clause No. 2 of Particular conditions of contract. In case of Security Deposit by way of B.G., you are required to deposit Rs. 25,000/- (Rupees: Twenty Five Thousand only) in Cash/DD to our Accounts Department on or before the execution of this purchase order, on which no interest shall be payable. The balance Security Deposit amount, i.e. Rs. 75,000/- (Rupees: Seventy Five Thousand only) shall be submitted in the form of Bank Guarantee as stated in Clause No. 2 of Particular conditions of contract.
6. The prices for essential spares quoted by 2 years operation and as per MOM dtd 25.3.98 shall remain valid for 2 years from the date of LOI/PO which can be supplied by you within a week time from the date of receipt of our order /intimation and payment for the same shall be made within 30 days after receipt in good condition.
